Re: Discontinuation of operation of certain National Bank of Greece (Cyprus) Ltd Branches

With a view to implementing the commitments undertaken by the NBG Group in the context of the Restructuring Plan agreed between the Hellenic Republic and the European Commission for the recapitalization of National Bank of Greece S.A. in 2012, and after non-completion of the procedures regarding the sale of National Bank of Greece (Cyprus) Ltd (NBG Cyprus), NBG Cyprus is obliged to restructure its overall activities and operations.

Accordingly, it has been decided to close the following Branches:
